### Tenderers are advised of the following:

#### *Clarifications to the RFT*

1. The *Australia Indonesia Partnership for Decentralisation (AIPD) Delivery Strategy 2010 – 2015* (as of 4 February 2010) provided with this Addendum 1 is final and supersedes any previous versions.

The version of the Delivery Strategy provided with the RFT on 23 January 2010 was a draft; however Tenderers are advised that no significant changes have been made to the structure of the Delivery Strategy.

2. As referenced in Clause 1 – Tender Particulars of Part 1 of the RFT, the following attachments are provided in Microsoft Word format to facilitate the preparation of Tenders:

3. Delete **Table 3: Performance Payments** of Part 4 – Basis of Payment and replace with the attached **Table 3A: Performance Payment – Nominated Base Rate** and **Table 3B: Performance Payments** (see page 3 of this Addendum).
4. Delete **Clause 3.3** of Part 4 – Basis of Payment and replace with the following new **Clause 3.3**:

“3.3 Performance payments are based on the six-monthly assessment of the Contractor’s performance in accordance with **Annex 4** of Schedule 1 – Scope of Services and actual amounts payable are calculated in accordance with **Tables 3A and 3B** of this Schedule.”

5. **Q:** How much is the contract value?

**A:** AusAID has not determined a set value for this tender. The final contract amount will depend on the financial proposal of the winning tenderer and subsequent contract negotiations.

6. **Q:** Please advise which countries are eligible to participate in this tender.

**A:** The Australian aid program is untied. Tenders are welcomed from any country.
